COVID- 19 Rapid Response Grant

Responding to Needs

The Henry County Community Foundation (the Foundation) board of directors has created a COVID-19 Disaster Response Fund to provide immediate funds to nonprofit organizations and local government efforts to help with relief in response to the current pandemic. Money for this fund comes from the Choose Henry Flex Fund for community grants and donations from citizens who can donate online on our [website](#) to the COVID-19 Disaster Relief Fund. All donations stay locally to help Henry County and residents to get through the crisis created by the pandemic.

“Our approach to community needs include Response, Recovery and Resilience through this period of fighting the virus, recovering from the virus when the economy, reopens and also to help with resilience, returning to some normalcy later.

We want to also be better prepared for the possibility of another wave or emergency,” said Beverly Matthews, Executive Director of the Foundation. The Henry County Community Foundation has donated Rapid Response Grants to the following:

- \$2,000 to Second Harvest Food Bank, serves local food pantries & provides tailgate food distribution
- \$2,000 to Southwest District Ambulance, front line responders to southwest Henry County
- \$2,000 to New Castle Schools for E-Learning teaching supplies for semester completion.
- \$4,000 to Emergency Management Office – secure generator power during power

- outages
- \$4,000 to Henry County Health Dept. – secures & connects to EMO during power outages.

The Foundation has reached out to local 501c3 nonprofits, schools and front line emergency entities who are dealing with immediate needs and invited them to apply for a grant. Qualified nonprofit organizations can now apply for grants in the amounts of \$1,000 to \$2,000 if needed at <https://www.henrycountycf.org/grants/>.
