– Butch Fairchild 1944-2017

Some people touch a lot of lives in a positive way that were guided by their own sense of purpose. Even though Dillard “Butch” Fairchild passed away in 2017, his life will continue to touch lives in the future through the Butch Fairchild Memorial Scholarship Fund established by his life partner, Gail Parka.

Butch was a Vietnam Veteran, business owner, Chrysler employee, body builder, a car restorer and creator, whose knowledge and interests led him to help others and facilitated his own success in many endeavors. But more than any of these things, Butch Fairchild was a good man – a champion for others who missed opportunities through no fault of their own or who were bullied in life.

He was an artist, according to his sister, Shelia Fairchild Preston, who said, “He created a beautiful canvas of a life well lived out of humble circumstances that were noble.”

Many met Butch at B&G Gym, a business he owned with partner, George Carter. A personal trainer who achieved the title, Master’s Mr. America in 1986, Butch helped others achieve their physical goals and will help many more achieve goals of success through his scholarship.

In addition to helping others reach their body-building objectives, he loved building cars and Hot Rods. Butch and Gail built their own hot rod together, completing one of his ‘bucket list’ dreams. As members of the Road Kings Car Club, they enjoyed participating in car shows all over the state.

According to Gail, “Butch wanted to leave money for a deserving New Castle student to attend a technical school.” Establishing a scholarship would assure that Butch’s wish could be fulfilled.

Just as unique as their “Hot Rod” was, Gail found a unique

way to create the scholarship endowment. With help from a local realtor, she sold Butch’s house in New Castle that she inherited after his passing, and fully funded the endowment that would honor his life.

Beginning in 2021, every New Castle Career School student who receives the Butch Fairchild Memorial Scholarship will have a lifelong friend, just as Butch wanted.

Although Tuesday, Sept. 10 was a warm, late-summer evening in Lewisville, those attending the seventh-annual Women’s Circle of Friends Grantmaking Gala were seeing visions of city street lights, snowflakes and all the holiday charm that downtown New Castle can muster through the eyes of Carrie Barrett.

As a result, Barrett snagged a check for \$5,350 to go a long way toward new Christmas garlands and banners for downtown light poles.

Barrett is executive director of New Castle Downtown (formerly New Castle Main Street), an initiative of the Indiana Office of Community and Rural Affairs. She and husband Matt wrote a humorous poem that painted a picture of the beauty of Broad Street in all its holiday glory, and the need for new decorations to grace the 85-to-115 new light poles going in.

Runners-up were Hope Initiative and Developmental Services, Inc., each receiving \$250.

Interlocal Community Action Program Director of Health Services Nancy Lewis accepted an endowment women’s-health check for \$1,039 for mammograms.

The annual evening at The Gathering in Lewisville, is a project of the Henry County Community Foundation’s Women’s Circle of Friends. Foundation President and Executive Director Beverly Matthews said, “Since 2012, \$46,014 has been granted to Henry County nonprofits.”

Katelyn Goodpaster, a New Castle High School senior, is the 2019 recipient of the Henry County Community Foundation Lilly Endowment Community Scholarship. In addition to full tuition at any Indiana college, Goodpaster will receive an annual \$900 stipend for books and other required equipment.

When speaking with Katelyn about the scholarship, she noted how she has been working towards this scholarship since elementary school. "For me, receiving the Lilly Endowment Scholarship is validation for years of hard work, perseverance and sacrifice not only on my part, but on my family's as well. I will never be able to put into words the gratitude I have for my parents, my teachers, and all of the people who have guided me on my path to success. This opportunity is a blessing, and I can't wait to make the most of it as I pursue higher education."

Katelyn is the daughter of Anthony and Angel Goodpaster. She was on the Speech and Debate Team at New Castle for 4 years, and was a member of National Honor Society. Katelyn served on the T.A.S.C. (Teens About Serving the County) Youth Grants Committee since 8th grade and was in a leadership role her final year. She founded the local chapter of Next Generation Politics, a 501c3 nonprofit dedicated to nonpartisan political education amongst Generation Z. She also served as Indiana State Director and was on the National Student Officer Board. Katelyn is attending Earlham College.

2019 Lilly Scholar Finalists

The finalists for the Henry County Community Foundation 2019 Lilly Endowment Community Scholarship Program are Carly Allen, Shenandoah High School; Samantha Burgess, Blue River Valley High School; Jeffrey Davis, Hagerstown High School; Hannah McKellar, Tri High School; and Devyn Schaetzle, Knightstown High School.

Every graduating senior attending Blue River Valley, Hagerstown, Knightstown, New Castle, Shenandoah, Tri and Union high schools, who is also a Henry County resident, is eligible to apply for the Lilly Endowment Community Scholarship. Each school corporation nominates one student to represent them in the Henry County Community Foundation's scholarship selection process. The Foundation's scholarship committee, from outside the county, narrows the field to a nominee and two alternates, whose names are forwarded to Independent Colleges of Indiana, Inc.(ICI). ICI makes the final selection of Henry County's 2019 recipient.

ICI is a nonprofit corporation that represents 30 regionally accredited degree granting, nonprofit, private colleges and universities in the state. This scholarship is the result of a statewide Lilly Endowment initiative to 1) help Hoosier students reach higher levels of education; 2) to increase awareness of the beneficial roles Indiana community foundations can play in their communities; and 3) to encourage and support the efforts of current and past Lilly Endowment Community Scholars to engage with each other and with Indiana business, governmental, educational, nonprofit, and civic leaders to improve the quality of life in Indiana generally and in local communities throughout the state. There are 143 scholarships awarded statewide.

DICK RILEY LEAVES A LEGACY



Richard “Dick” Riley was a 1960 New Castle High School graduate who inspired everyone he met. Even though he and his wife, Carolyn, (NCHS Class of 1961) haven’t lived locally since they graduated high school, they continued to support their hometown through the Dick and Carolyn Riley Named Fund within the Choose Henry Flex Fund.

When Dick passed away on May 18, 2019, his family returned to New Castle on June 26 to plant a tree in his memory at Baker Park. It’s people like Dick who touched our community in a positive way and leaves a permanent legacy of doing good.

Donor Advised Funds

This year, the Henry County Community Foundation awarded **\$149,428.00** in grants to organizations recommended by their donors. This type of fund is especially helpful for donors, who for tax or estate planning reasons, want to take a tax deduction one year and spread the contributions over future years.

Agency Endowment Funds

Agencies and organizations create endowment funds as a way to secure their future. By establishing an endowment within the Henry County Community Foundation, the nonprofit group builds assets that the Foundation will manage. This year, grants totaling **\$77,209.00** were awarded from Agency Endowment Funds.



Second Harvest Food Bank provides food to local food pantries in Henry County and also distributes food at monthly "tail gate" distributions, staffed by local volunteers. Second Harvest has an agency fund at the Foundation which pays out an annual income to the organization to be used for their good work in the community.

Field of Interest Funds

Field of Interest Funds allow donors to address an issue or cause they care deeply about without naming specific charities. The Foundation takes those concerns into consideration when making grants to appropriate programs that fit with the donor's category of concern.

This year the Foundation awarded **\$33,507.60** from Field of Interest Funds.

The "All 4 Kids" Field of Interest Fund, established by Melissa Millikan and her husband, Dr. Nathan Millikan, supported Victory Lane Camp in 2019. Centered around families who have children with disabilities, Victory Lane Camp provides connections between families that lead to lasting friendships where families support one another through the stresses and joys of life all year long.



Designated Funds

The Henry County Community Foundation awarded **\$570,005.07** in grants from Designated Funds in 2019. These funds benefit specific eligible organizations selected by the donor. If an organization ceases to exist or changes its purpose, the Foundation Board of Directors preserves the donor's intention by redirecting the funds to an organization with a similar purpose.

Scholarships

This year, the Foundation awarded 360 scholarships totaling **\$416,653.84** from 145 Scholarship Funds to assist students pursuing higher education. Scholarship recipients are listed on the Foundation's website at www.henrycountycf.org. Scholarships are great for donors wishing to invest in Henry County through higher education. They may be used to further the education of graduates from a particular high school, students in a specific field, or those enrolled at a chosen institution.



The Henry County YMCA has been providing programs for all ages since 1919. The William R. & Marceline Heck Family Fund has supported the YMCA since 2002 through their Designated Fund.



The Charlotte McClurg Business Scholarship was established in 2019 in her memory by her husband, Gary. Charlotte was a long-time educator at Knightstown High School and the scholarship is for a Knightstown graduating senior who is pursuing a business related degree.



Creating good in the community takes many individuals who are willing to contribute their time, talent and treasure. According to Beverly Matthews, president of the Henry County Community Foundation, “Ray Pavy’s dedication to the Henry County Community Foundation is rarely duplicated and only the Judy Melton Award can honor such distinction.”

Pavy was recognized for his long time dedication to the Foundation for his board membership and lengthy leadership on the scholarship committee at the 2019 Annual Meeting on June 20.

When describing Pavy before the reveal, Matthews said, “On a rare occasion, someone from our community stands out – not just at the local level, but also the state and even national level. Their story is so interesting that it seems never ending because it never gets old.”

Many accolades have been awarded to Pavy for his outstanding basketball career at New Castle High School and at Indiana University before an accident left him unable to play. Those odds didn’t stop Pavy from living a remarkable life of service to his community in New Castle and Henry County.

A long time donor and board member, Pavy helped guide the Foundation from the beginning and expanded his generous reach to thousands of youth who continue to benefit from a scholarship named after him. His service doesn’t end there. He has been an integral part of the Foundation’s scholarship committee and has served for over a decade as a local liaison to the Lilly Scholarship panel judges outside the county.

“Dedicated to the Henry County Community Foundation,” Matthews added. “We are forever grateful to Ray for sharing his star status talent off the court with us and into the arena of being our number one cheerleader.”

Judy Melton was a past president and board member of the Henry County Community Foundation. In addition to her service as a tireless volunteer, and with her English teacher background, she took the responsibility of producing all of the formal communications that the Foundation published. Her dedication through her time, talent and treasure from 1993-2005 to the Foundation is rarely duplicated.

This honor is awarded to individuals for “Making a difference in Henry County, exemplifying philanthropy through time, talent and treasure” and is selected by the board of directors. When Judy passed away in December 2009, a memorial plaque with her engraved picture was placed in the Foundation office to remind members of the organization, that it is people like Judy - whose commitment and hard work have paved the way for our success and to recognize others who go above and beyond expectation.

Congratulations go out to Ms. Emily Whaley who received the 2019 Henry County Community Foundation Teacher Excellence Award. Ms. Whaley is a Mathematics teacher and Data and Technology Integration Coach at Shenandoah High School.

The Teacher Excellence Award is the highest honor the Foundation can bestow on an individual in education. The honor is designed to recognize teachers who have demonstrated an outstanding commitment to inspire students to reach for difficult and lofty goals. Persons to be recognized have earned the respect of students, parents and peers through sustained effort, high moral standards and the likelihood of enduring beneficial effects on the students with which they have worked.

Not all nominators choose to be revealed, but Greg Allen, principal of Shenandoah, was proud to nominate and tell the community about the wonderful educator he works with. “Emily Whaley is an excellent educator who is dedicated to her students, our school, and to our community. I cannot think of a better example of an exemplary teacher.” In his application Allen shared “(Her) dedication to students at Shenandoah is unrivaled by any teacher I have been in contact with in 22 years as an educator.”

Ms. Whaley teaches Algebra, Pre-Calculus and Trigonometry. She was instrumental in bringing dual credit and early college opportunities to Shenandoah through her own interest in meeting the needs of the students on campus. She serves as a student council advisor and a data/technology coach for Shenandoah. This year Ms. Whaley stepped up to teach a 7:00 a.m. class when another teacher became seriously ill. Not only did she teach the class, but she began coursework for dual credit certification to benefit the future of her students.

Allen summed up his nomination saying, “Emily Whaley is a leader in our school, the community and her church. Mrs. Whaley stands up for what she believes. She balances an incredible amount of responsibility with what seems like relative ease. (Her) work ethic, abilities and personality make her a perfect fit for any high school. Shenandoah is blessed to have (her) as a teacher leader.”

How big does a scholarship have to be?

According to Forbes magazine, the “Price of College is Increasing Almost 8 Times Faster Than Wages. Student loans make up the largest chunk of U.S. non-housing debt – more than both credit cards and auto loans.”

National news like this even affects students in our community and region. When the Henry County Community Foundation was established in 1985, a student could get a four-year degree at a public university for \$11,812. Today, the average annual in-state college tuition in Indiana is \$36,448 for a four-year degree. That’s over a 208% increase and doesn’t include room and board for those students who live on campus.

Scholarship endowment levels at the Henry County Community Foundation started at \$5,000 in 1985 and they were main drivers of investment in the community. Trying to keep up with college costs to help students in their college debt burden, the scholarship endowment level was raised to \$12,500 in 2008 to generate a \$500 scholarship.

In order to help more students succeed in attaining a degree and not be so burdened in liability, the Henry County Community Foundation board of directors voted to increase the scholarship endowment level minimum to \$25,000, effective January 1, 2020. **What does this mean for the 145 current scholarship funds?**

Current established scholarships will continue to pay out at their endowment levels, and in 2019, that total amount was \$416,454. The Foundation would like to work with donors of these scholarships and explore ideas to grow their capacity.

Receiving a scholarship of any amount is an honor – to both the student and to the donor, who created the scholarship. The Foundation’s scholarship donors have been so generous that their contributions make up 35% of our total assets.

The Henry County Community Foundation is a strong believer in helping our youth obtain their education goals. They make our world a better place. Beginning on January 1, 2020, when scholarship endowments require \$25,000, these students will be better equipped to finish their degrees with less debt. 


